LAFCO File No. 2004-02 a request by GCID and Williams Development Group to detach 40.73 acres of inhabited territory from the Glenn Colusa Irrigation District on property located west of I-5 within the City of Williams on property known as the Eastside Project: Unit 2, Phases 3, 4 and 5; Book 2 of SUBD's, pages 2, 5 and 9 of the Valley Oaks Subdivision.

Action: Conduct Public Hearing and Consider Resolution 2005-02 deleting 40.73 acres from the Sphere of Influence from Glenn-Colusa Irrigation District and Resolution 2005-03 detaching 40.73 acres from the Glenn-Colusa Irrigation District.

LAFCO File No. 2004-03 a request by GCID and Williams Development Group to detach 135.86 acres of uninhabited territory from the Glenn Colusa Irrigation District and includes a portion of the currently developing area within the Valley Oaks Subdivision consisting APN's 016-320-103 and 005-340-01 through 80.

Action: Conduct Public Hearing and Consider Resolution 2005-04 deleting 135.86 acres from the Sphere of Influence from Glenn-Colusa Irrigation District and Resolution 2005-05 detaching 135.86 acres from the Glenn-Colusa Irrigation District.

Pursuant to Government Code Section 54954.2, Commission members may make a brief announcement or report on activities. Commission members may also provide a reference to staff or other resources for factual information, request staff to report back to the Commission at a subsequent meeting concerning any matter, or take action to direct staff to place a matter of business on a future agenda.

Public Comment

Members of the public may address the Commission on items not appearing on the agenda, as well as any item that does appear on the agenda, subject to the following restrictions:

- Items not appearing on the agenda must be of interest to the public and within the Commission's subject matter jurisdiction.
- No action shall be taken on items not appearing on the agenda unless otherwise authorized by Government Code Section 54954.2 (known as the Brown Act, or California Open Meeting Law).
- The total amount of time allotted for receiving public comment may be limited to 15 minutes.
- Any individual's testimony may be limited to 5 minutes. Time to address the Commission will be allocated on the basis of the number of requests received.

Public Hearings

Members of the public may address the Commission on any item appearing on the agenda as a Public Hearing. The Commission may limit any person's input to 5 minutes. Written statements may be submitted in lieu of or to supplement oral statements made during a public hearing.

Accessibility

An interpreter for the hearing-impaired may be made available upon request to the Executive Officer 72 hours before a meeting.

The location of this meeting is wheelchair-accessible.

Disclosure & Disqualification Requirements

Pursuant to Government Code Sections 56100.1, 56300(b), 56700.1, and 81000 et seq., and Colusa LAFCO's Policies and Procedures for the Disclosure of Contributions and Expenditures in Support of and Opposition to Proposals, any person or combination of persons who directly or indirectly contribute \$1000 or more or expend \$1000 or more in support of or opposition to a change of organization or reorganization that has been submitted to Colusa LAFCO must comply with the disclosure requirements approved by

Colusa LAFCO. These requirements contain provisions for making disclosures of contributions and expenditures at specified intervals. Additional information may be obtained at the Colusa County Elections Department 546 Jay Street, Colusa , CA 95932. (530) 458-0500

A LAFCO Commissioner must disqualify herself or himself from voting on an application involving an “entitlement for use” (such as an annexation or sphere amendment) if, within the last twelve months, the Commissioner has received \$250 or more in campaign contributions from the applicant, any financially interested person who actively supports or opposes the application, or an agency (such as an attorney, engineer, or planning consultant) representing the applicant or an interested party. The law (Government Code Section 84308) also requires any applicant or other participant in a LAFCO proceeding to disclose the contribution amount and name of the recipient Commissioner on the official record of the proceeding.
